



## **Welcome to Persian rap token**

### **Defitunes Platform: Beta Version**

**At the outset of the project, our goal was to introduce the PNRT token as part of the Defitunes platform and to enable further interactions such as buying and selling once the platform was fully launched. However, technical complexities and the need for extensive testing have caused delays in the development and launch of the platform. Given this delay, we decided to update the token information and present it independently. Users can now interact with the PNRT token, and this decision has been made to facilitate user interactions and clarify the status of the token. It is also possible that the various features of the Defitunes platform may not work properly, and the reason for that is the development and various updates on the website. The delay in updating the token is due to the complexities of developing the Defitunes platform. We are diligently advancing the project and working with developers to deliver all the desired features and functionalities. We hope this explanation addresses any concerns and that the PNRT token will be approved and accepted.**

## **Introduction:**

At the heart of the underground rap music community, independent artists have created works with burning love and passion that have penetrated hearts beyond financial and commercial boundaries. For more than two decades, this cultural movement has continued without external financial support or commercial sponsors, and independent artists rely on personal resources and the support of the fan community to create and produce music. The PNRT token is a symbol of this independence and self-sufficiency because it is rooted in a culture that stems from the honesty and endless creativity of our artists. We are proud to introduce our music fan token, the PNRT token, an innovation in the blockchain world specifically designed to support and empower independent artists. This token acts as a new tool to create a direct connection between artists and their fans, providing new opportunities for monetization and professional growth. This token allows artists to offer rewards, special content and exclusive experiences to their fans. which strengthens the relationship between artists and fans. The PNRT token is designed purely as an advocacy and communication tool and has nothing to do with branding issues. This token helps independent artists to quickly and effectively benefit from their financial support and communication without the need for trademark registration or related legal problems. Also, our fan token focuses on three important principles:

### **Transparency and financial stability**

It is committed to providing accurate and up-to-date information through website articles and social networks about all decisions and activities related to Token on the [bscscan.com](https://bscscan.com) website. Also, the addresses to which the token belongs have been locked for a longer period of time and the minimum release has been considered for these addresses so as not to cause problems or disruptions during the sale or transfer of fan tokens for users and fans.

### **Security and stability**

Various codes are included in the token contract, which informs users and fans in case of problems and protects their capital, such as: stop token transfer, relinquish ownership, freeze and blacklist.

### **Choosing community members from among users and fans**

The collective members play an important role in shaping the future of the PNRT token, and in each three-month period, the top ten addresses that hold the most tokens in one address are among the community members, chosen from among the dedicated users and fans who play an important and key role. For example: they can determine when to block or blacklist addresses of infringers, or they are responsible for determining when to lock tokens and cash pools and ...

## **Token introduction:**

### **What is the token of PNRT**

The PNRT Token is an innovative way to fund and generate revenue, allowing artists to connect with their community as well as fans from around the world. PNRT token is similar to digital currency, as it uses blockchain technology to create and transfer tokens securely and transparently. The PNRT token is an innovative and powerful concept that has the potential to revolutionize the underground music industry and create new opportunities for artists and fans, and can have different features and functions depending on issuers' preferences and goals. It is also a way to express support and appreciation for independent artists. Token is currently active on the Binance Smart Chain network and users and fans can use it.

### **The reason for the emergence of Persian rap token**

One of the reasons for the emergence of the PNRT token is the increasing popularity and innovation of blockchain technology, which enables the creation and distribution of authentic, secure and transparent digital assets. Blockchain technology also enables the creation of decentralized platforms and marketplaces, and eliminates the challenges of the music industry, which is affected by the rise of streaming services on unofficial websites and non-respect of artists' copyrights. (1) Decentralization on the web2 and the distribution of artists' works and their support relies on centralized websites that are controlled by certain people and are vulnerable to censorship, manipulation and hacking. (2) High broadcasting costs and time consuming for independent artists on Web2. (3) A direct interface between Token and the platform that connects fans to artists and avoids paying additional fees, and users and fans can use artists' works or products on a free platform with the PNRT token interface.

### **How does the PNRT token work**

Each token needs a network to function and confirm transactions. The PNRT token is active in the Binance smart chain network, and one of the reasons for choosing this network is its low and fast network costs, which is very important when the network is crowded. To use the PNRT token, one must have a crypto wallet that supports the blockchain network and the BEP20 standard. Use web wallets like Metamask and Trustwallet or their app. PNRT token can be purchased with USDT and WBNB by connecting to PancakeSwap which is a decentralized exchange and after purchase you have some fan tokens in your wallet which you can use to access gifts and rewards from different artists, buy artwork or products, vote on specific decisions related to a music project, receive exclusive merchandise deals, and trade on other platforms that support them. These are some of the first steps and information on how to use the PNRT token, which may have different details and changes depending on the project or platform. ## **What are the purposes of token PNRT**

Creating a new market for underground artists as well as making fans more familiar with the benefits and potential of blockchain and its various applications. For example, PNRT tokens can demonstrate how blockchain can enable transparent, secure and decentralized transactions and management, providing a source of income. and new partnerships for independent artists or composers who create new works at their own expense, as well as increasing users and popularity among fans of any underground music genre. Artists or composers can sell their fan tokens to raise money for their projects to create more lasting works or use them to reward their most loyal and active fans. Eliminating fake users or accounts that can broadcast the works of independent artists without permission and such cases that cause artists to lose their fees. Here are some examples of token purposes that artists can use using the platform:

- Support anywhere in the world
- Independence of artists and composers
- Transparency in financial support for artists
- Without intermediaries and without personal involvement

## **Benefits and features of PNRT token**

Supporting your favorite artists who are far away from you requires specific information such as address, phone number or bank account number, which sometimes does not work or takes time, but in the blockchain network, supporting artists is simple and possible. . For example, on Defitunes dedicated platform designed for PNRT token, the wallet address of artists who are members of the platform and have verified their account is available and visible, just search for your favorite artists or composers, Wallet addresses are verified, find them. And send them tokens in the shortest possible time. (shown in the artists section of the platform) The PNRT token is also tradable on secondary markets, creating a new source of income for the artist and fan that has never been more decentralized and transparent in Web 2.0. Direct and interactive communication between artists and fans strengthens the relationship between artists and fans, and the PNRT token can help artists build a stronger and more active community, as well as monetize their work and talent in a fair and creative way. Fan Token can create new opportunities for collaboration and innovation in the underground music industry, which can be mentioned as a few examples of things that can be used using PNRT Token on the Defitunes platform:

Be it fans or artists of different genres, emerging talents or product sellers, they all gather on one platform and have a free way to sell works and products using PNRT token through the Defitunes platform. The chat feature on the platform is a way for fans and artists to connect. Artists find each other and interact directly on the platform, and the result of their projects will bring satisfaction to the fans, which will definitely be appreciated. Saving time and running costs, artists can access the following features by setting up an account and verifying the account on the website:

## **How to use token PNRT**

Users or fans can send tokens to support their favorite artists. First, you need to add the fan token to your Metamsk wallet or trustwallet. Here we will add Metamsk. Log in to your Metamsk wallet. Go to the bottom of the page. You will enter a new page. On this page, click on the manual add tab and enter the token details and click save at the bottom of the page to add the token to your Metamask wallet:

Congratulations, you have added the PNRT token to your wallet. Now you need to buy the fan token. You can buy the fan token with WBNB and USDT currency pairs. To buy with any currency pair you want, for example, click on WBNB. Enter the page. New in Metamsk wallet, click on Swap a little lower to enter the new page for swap. On this page, WBNB is located at the top. In the bottom box, search for the name of the PNRT token. Now specify the number of WBNB that you want to swap . and confirm it, wait a little while until the network fee and the number of exchanges or swaps are determined. By confirming again, it will take some time for your WBNB to be swapped to PNRT tokens, after that you can see the number of your tokens in your walletYou have a number of PNRT tokens in your Metamask wallet, and you can use these tokens to purchase artists' works or their products using the Defitunes platform, which is specially designed for the token. You can also be a member of the community by keeping the

token. A number of tokens are assigned to them. The PNRT token has different uses and capabilities that you can find out about the latest news and capabilities every month or period through the website, platform or social networks.

## **PNRT Token security:**

### **Security codes in PNRT token and Defitunes platform security**

Security and transparency in PNRT token. For more trust and to keep the assets of users and artists safe, we have created four layers of security in the fan token contract to prevent hacking or fraud and the like in certain situations. Freeze and blacklist functionality can be implemented separately through the platform, and if the violators repeatedly do not provide services to users and fans, it is done by the token freeze or blacklist contract.

#### **Freezer:**

##### **The first security code in the PNRT token contract**

In some cases, artists put music up for sale, but after receiving payment, users cannot receive the music, or sellers charge for the product but do not ship the purchased product to users, or cases where users And the fans pay, but they They do not receive a product. Users report anti-performance reports of violators through the support platform And account restriction is done in three steps.

On reporting the first violation: the platform will disable the offending artist or seller's account for a month.

On a second violation report: the platform will disable the offending artist or seller's account for three months.

In the third violation report: the violator cannot withdraw or transfer the token for six months , and that address is restricted through the freezing feature on the platform and the token contract. (In the first two reports, offenders cannot upload music, albums or products to the platform until security issues are resolved) This feature is done to protect the security and property of fans and users. Users and fans can report violations by artists or sellers through communication channels or email.

### **Blacklist:**

The second security code written in the PNRT token contract.

Violating artists and sellers try to bypass the platform, fans and users, and in the first three stages and restricting the user account, if the violators have not solved the problem, they will be reported to them with multiple reports under the title of countermeasure, the user account will be added to the Black list and they will be banned from activity for a different period of time and will not be able to sell music, sell products, sell concert tickets through this platform. Blacklisting is done both through the platform account and through the block in the token contract. Account deactivation and blacklisting can take anywhere from one year to two years depending on individual violations, and community members decide via polls for violators.

### **Token Transfer Stop:**

The third security code written in the PNRT token contract.

In some cases, the token encounters an obvious bug or problem after the update, and the assets of users and fans are at risk. In such circumstances, all transfers will be postponed until problems and bugs are resolved, and during this time, all users and fans will be informed through the website and social networks. A very important feature to secure the assets of users and fans is included in the PNRT token contract.

### **Ownership of contract rejected:**

The fourth security code written in the PNRT token contract.

This very important feature means that a certain person or group does not own all the tokens and cannot transfer or add commands to the contract code on their own. In addition to this code in the contract, the members of the community also play an important role in the decentralization of PNRT Token, who are selected from active and committed users and fans. And they have to decide whether the code should be added to the contract or not.

## **What does the mint feature mean in the PNRT token contract code**

A unique feature designed for fans and users, new tokens will not be added until 100% of PNRT tokens are released. This means that every token you buy will gain more value and importance and you will be part of an exclusive group. The last release period of PNRT token belongs to the Defitunes platform, which will be released on (2029/04/04) and no token will be released until this date, and this date can be extended by community members after the deadline, and they can set a new date to lock the token. Defitunes platform offers, the only requirement to add new tokens is to release all tokens. Only community members can decide whether or not PNRT Token Minting will take place after all tokens have been issued.

## Community members and PNRT token liquidity

The initial liquidity of the token was provided by the platform, which was one million tokens, and the cost of issuing other tokens in different periods is provided by the platform and fans. The platform makes a significant contribution to liquidity in any period through advertisements and fans by maintaining the value of the token.

A clear and remarkable approach in the PNRT token project is the involvement of community members, who are selected from the top holders—those who maintain the highest number of tokens in a single address—to have a greater impact on the project. The community members have key responsibilities, including setting the lock duration for liquidity pools, restricting violators' accounts through the platform or the blacklist code in the smart contract, and determining the release time for locked tokens after the 22nd period. These decisions are made to enhance transparency, security, and better control over processes.

A total of 2 million PNRT tokens will be distributed across 30 period to the top ten addresses in each period. Each period lasts three months or 90 days. Addresses that have been allocated tokens, such as the development team, platform, etc., are not included in these top ten addresses. Only addresses of users and fans who keep the most tokens in one address. To check the selected top ten addresses, you can visit the website [www.bscscan.com](http://www.bscscan.com) or view the top ten addresses in the community members section on the official PNRT token website.

Token calculation in each period :

$$2.000.000 \div 30 = 66.666$$

## Token release:

### Release of PNRT tokens every three months

Locking tokens and releasing them in different rounds that cannot be transferred, staked or sold is one of the methods of managing the supply of tokens in the market. The total number of tokens is 21 million tokens, of which 9 million tokens belong to different addresses that have been locked at different times. A certain number of the remaining 13 million tokens are released in each period. The first release period of tokens is on 2025/09/23 , and until this time 12 million tokens are locked. Each period is 90 days or three months.

The way to release tokens in each period is as follows:

The minimum release is 22 courses. After the completion of the courses, the community members decide to release the remaining number of tokens in the same way or choose other ways. The minimum release of tokens after the 22nd period is one hundred thousand tokens.( Maximum of 30 periods )

**Membership benefits:**

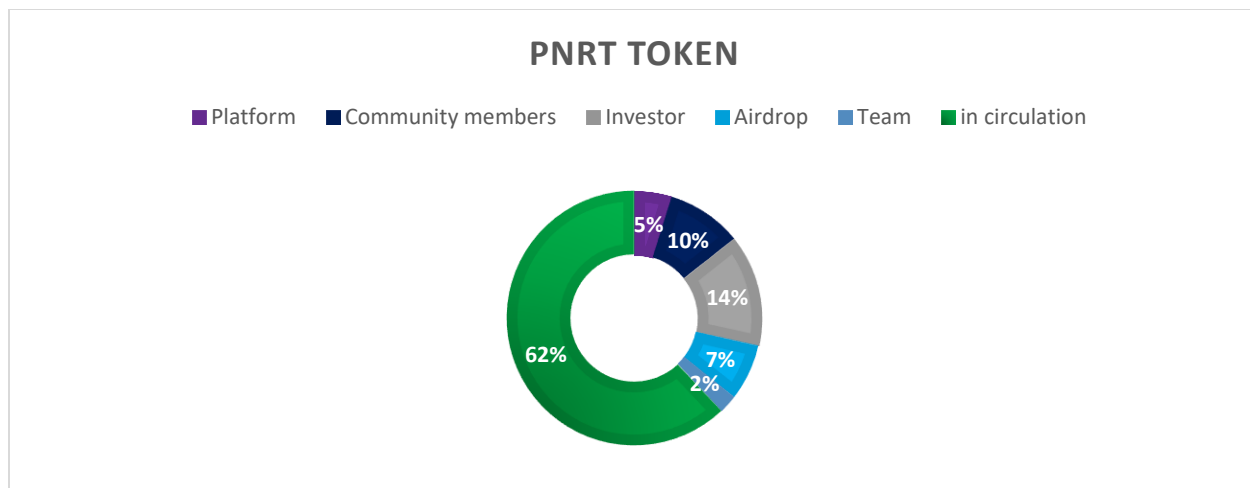
Being a member of Defitune not only provides special facilities to each group of artists, but also contributes to the overall growth and success of the platform and independent artists.
